without Tricolor is also its culture.

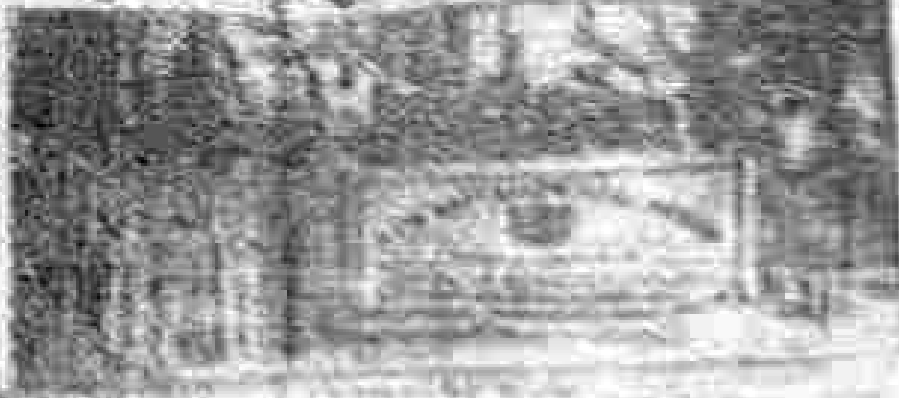

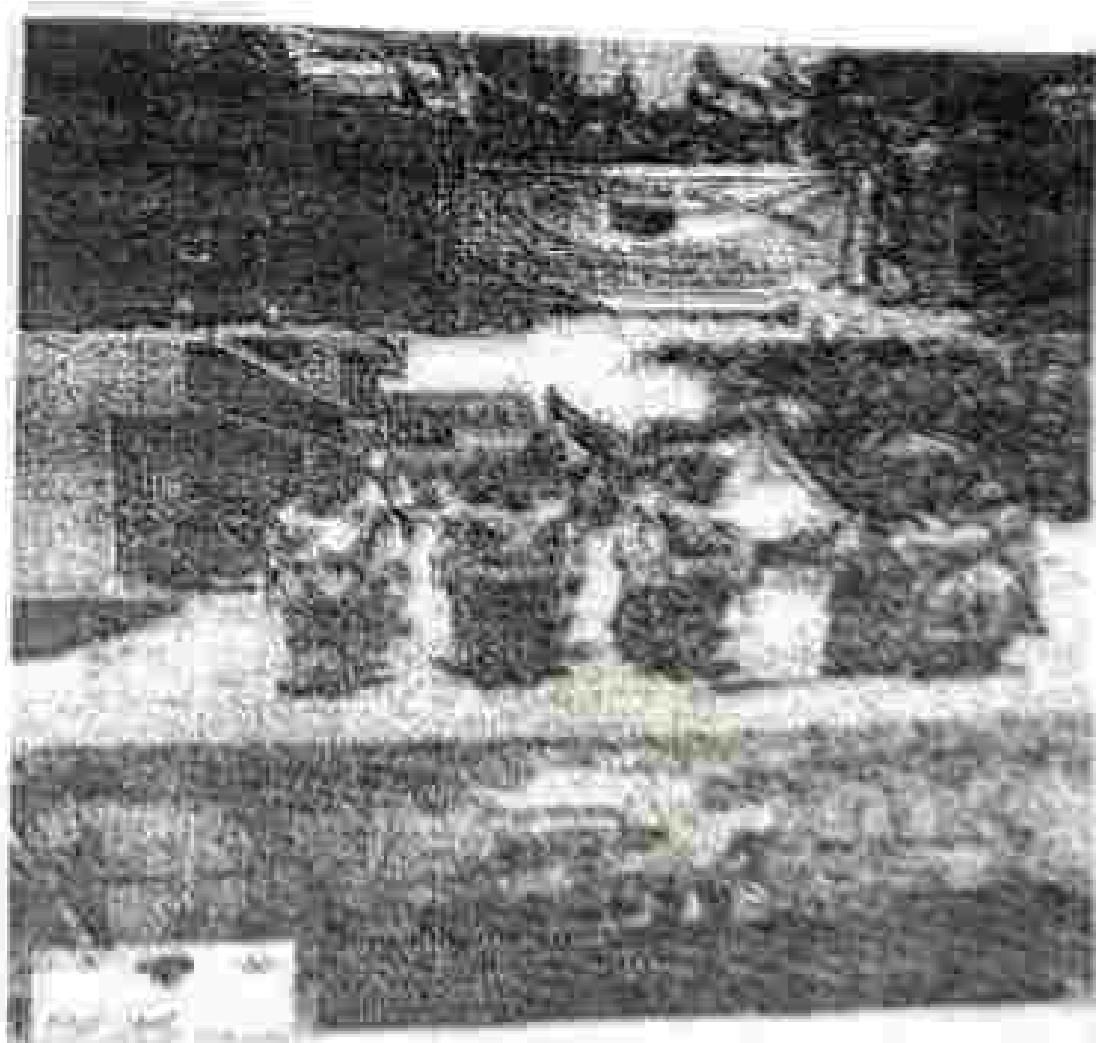

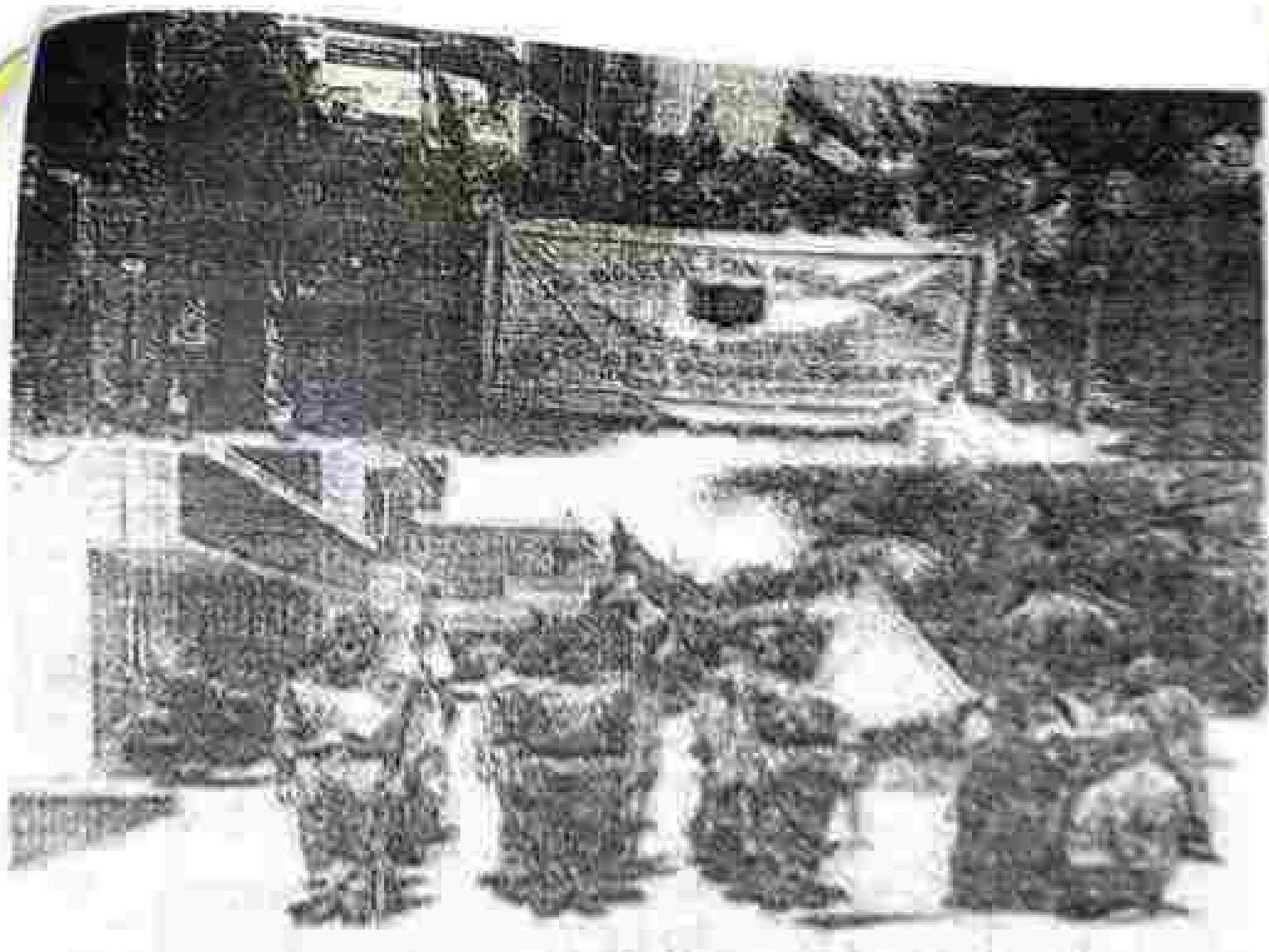
