19.	Eligibility Fee	Rs. 800	Charged from Students other than University of Jammu to be deposited in the University chest only once at the time of admission.

21.	Resource Mobilization Fund	Rs. 1443.50	5% of the total fee (less Rs. 1130/- realized as Corpus Fund) to be deposited every year in the University.

**Note:**

- 1) Library security deposited at the time of admission to the Course is refundable.
- 2) Claim for refund of Library security deposit shall be entertained only within six months after completion of the course or discontinuation of the studies whichever is earlier after which the amount shall lapse.
- 3) The fee shall not be accepted in installments; entire amount of prescribed fee shall be paid in full.
- 4) Fee once paid shall not be refunded.
- 5) Annual fee for re-enrollment to next consecutive year should be paid within ten days from the dates notified for the commencement of session, after which late fee under rules shall be charged.
- 6) The Fee structure is subject to revision by the University of Jammu from time to time.
