

OTHER INFORMATION

DOCUMENTS REQUIRED TO BE SUBMITTED ALONGWITH THE APPLICATION FORM

1. Two photo copies (duly attested) of Matric Diploma
2. Two photo copies (duly attested) of Matric Marks Card
3. Two photo copies (duly attested) of 10+2 Marks Card.
4. Two photo copies (duly attested) of State Subject (For J&K domicile only).
5. Two photo copies (duly attested) of category certificate (For candidates seeking admission under any reserved category)

DOCUMENTS REQUIRED TO BE SUBMITTED AT THE TIME OF ADMISSION

1. All the original documents from serial number 1 to 5 as stated above.
2. Original discharge certificate from the institution last attended alongwith two photo copies of the same duly attested. No candidate will be admitted in absence of this certificate.
3. Migration certificate in original alongwith two photo copies of the same duly attested (For candidates other than J & K State Board of Education).
4. An affidavit to the effect that the category certificate is genuine. (in case admission is granted under any reserved category)
5. An affidavit for the gap period (education gap) if any as per specimen attached at Appendix 'A' (Applicable to those candidates who have passed 10+2 examination before the current year i.e one year earlier or more and have not taken admission in any other course.
6. Eligibility Form : (students coming from other than Jammu province shall fill up the eligibility form of this University and submit the same to the College alongwith prescribed University fee)
7. Eight recent passport size coloured photographs.

CANCELLATION OF ADMISSION

The Admission Committee shall have the right to cancel the admission of any student who fails to produce the requisite documents/fees within the prescribed time after admission.

MINIMUM ATTENDANCE REQUIREMENT

As per Jammu University statutes governing 5 years integrated Law Course, a student has to attend a minimum of 75% of lectures delivered in the classes to be eligible to appear in any term examination failing which he/she will not be permitted to appear in the examination.

TERM PROMOTION

Promotion shall be regulated as per Jammu University Statutes as amended from time to time.

- a) No student shall be promoted from II to III semester unless the candidate has passed in two paper of Semester-I and fulfils the statutory requirements of attendance.
- b) No student shall be promoted from IV to V semester unless he has passed two papers i.e. I to III semesters of the semester examinations and fulfils the statutory requirements of attendance in IV semester.
- c) No student shall be promoted from VI to VII semester unless he has passed two papers of the semester examinations (I to Vth semester) and fulfils the statutory requirements of attendance in VI semester.
- d) No student shall be promoted from VIII to IX semester unless he has passed two papers of the semester examinations (I to VIIth semester) and fulfils the statutory requirements of attendance in VIII semester.

Provided that a candidate, who has been unable to appear in or complete the examination on account of illness or circumstances beyond his control, may on the recommendation of the Dean, Faculty of Law and with the approval of the Vice Chancellor be promoted to the next higher semester and allowed to appear in the paper/ papers in which has been unable to appear.

Provided that the application of such a candidate shall not be entertained unless it satisfies the following conditions.

- i) It reaches the controller of Examinations not later than the tenth day from the date on which the candidate was incapacitated from the taking or completing the examination.
- ii) It is accompanied by a medical certificate issued by the Civil Surgeon/Registered Medical Practitioner in case of illness or documentary proof in the case of absence due to circumstances beyond the control of the candidate.

Provided that every student shall qualify in all papers prescribed for five years Law Course from Ist to 10th semesters within seven years of joining the first semester of the said course failing which his/her examination shall stand canceled & he/she shall neither be allowed to continue Law Course as a regular student nor appear in any examination privately

STANDARD OF PASSING

Standard of passing shall be regulated by the Jammu University Statutes as amended from time to time.

In order to qualify for the 5 years degree of Bachelor of laws a candidate shall obtain not less than 40% marks in each paper and 50% in the aggregate.

Provided that a candidate, who fails in one or more papers at a Semester examination shall be allowed on the request of the candidate grace marks upto 1% of the total marks prescribed for a semester examination.

Provided further that the Vice-Chancellor may award one grace mark to a candidate who after getting the benefit of grace marks mentioned in the foregoing provision fails by one mark :-

- a) to qualify in all the papers prescribed for the first or second semester examinations; and/or
- b) to qualify in all the papers prescribed for the third or fourth semester examinations; and/or
- c) to qualify in all the papers prescribed for the fifth or sixth semester examinations; and/or
- d) to qualify in all the papers prescribed for the seventh or eighth semester examinations; and /or
- e) to qualify in all the papers prescribed for the ninth or tenth semester examinations.

NOTE:-

UNIT TESTS

A Unit Test is held in all subjects in each semester after the completion of each unit of the prescribed course. The test is held in the period of concerned subject without disturbing the teaching schedule of the other subjects. On the completion of the course a house test is also held in each subject/paper of the prescribed course.

NO MIGRATION

A student admitted to 5 Year Integrated Course in any of the affiliated college shall not be permitted to have migration, while pursuing the course, to the Deptt. of Law University of Jammu and vice versa.
